**RULES AND REGULATIONS**

- A. Groups using the Recreational Fields will be responsible for orderly behavior. **NO ALCOHOLIC BEVERAGES** are permitted within the parks.
- B. Parents or guardians must sign the permit for minors or youth groups requesting use of fields, and must assure adult chaperones at a ratio of one adult per 25 children for each event.
- C. You must specify the exact dates and times you would like to use the fields.
- D. Team rosters (including name, address and phone number of every player) must be submitted with every application form.
- E. In case of inclement weather, you will be notified by the Recreation & Parks staff if the fields at Zukor Park, Germonds Park and Lake Nanuet are not playable. All other field cancellations are left to the discretion of the permit holder. Failure to comply will result in immediate cancellation of your permit. No refunds will be given for rainouts. Makeup dates are available by calling the Recreation & Parks Office.
- F. Field requests are subject to final confirmation upon receipt of league rosters and schedules.
- G. Permits are not transferable. Changes in schedules must be reported to the Clarkstown Parks Board and Recreation Commission.
- H. Fields will be allocated on the basis of 2 hours per game including warm-up. No inning shall begin 15 minutes before the hour the permit expires. Permits will be issued for Germonds Park and Zukor Park starting at 10:00 A.M.. All other permits will be issued starting at 9:00 A.M..
- I. Leagues/Organizations/Tournaments must provide a Certificate of Insurance. Please see attached insurance requirements.
- J. In the event you will not be using a field on your scheduled date, please call the Recreation & Parks Office.
- K. All ball field maintenance should be done by Recreation & Parks staff only. If the fields are not playable, the game should be cancelled. If you were to play and damage was done to the field, you will be charged for repairs.
- L. **HOLD HARMLESS AGREEMENT**

To the fullest extent provided by law, the Contractor/Applicant and all of its employees and agents agrees to protect, defend, indemnify and hold the Town of Clarkstown and its officers, employees, and agents and save it harmless from and against any and all losses, penalties, damages, settlements, costs, charges, and professional fees or other expenses or liabilities of every kind and character in connection with or arising directly or indirectly out of this agreement and/or the performance thereof. Without limiting the generality of the foregoing, any and all claims, etc., relating to personal injury, death, damage to property, defects in materials or workmanship, or any other violation of any other applicable statute, ordinance, administrative order, rule or regulation or decree of any Court, shall be included in the indemnity hereunder, with the exception of claims, if any, caused by the sole negligence of the Town of Clarkstown.

The Contractor/Applicant agrees to name the Town of Clarkstown an additional insured on its liability insurance policies by way of policy endorsement and provide the Town with Certificates of Insurance or other evidence of insurance as may be required by the Town.
